O R D E R

In pursuance of the Director of Food Civil Supplies & Consumer Affairs Assam, Guwahati's order issued under Memo No. DS.146/2010/Pt./59 Dated-03/11/2011 regarding allotment of wholemeal atta to be produced by the Roller Flour Mills out of **additional PDS (TPDS)** allotted for the month of **October' 2011** and as per guidelines in this connections issued by the undersigned vide Memo No. KSL- 137/2005/12 dated 20-01-06, I Shri S.K.Roy, ACS, Deputy Commissioner, Kamrup Amingaon in exercise of the powers conferred by clause-26 read with clause-28 (b) of the Assam Public Distribution of Articles Order,1982, do hereby make the sub-allocation of aforementioned whole meal atta to the sub-whole sellers of Kamrup Sadar Sub-Division as shown below for lifting from the respective R.F. Mills **within 24-12-2011** on payment of price @ Rs. 737.90 per quintals for wholemeal Atta fixed by the Government and for distribution of the same through Public Distribution System at a quantum of **1.267 kilogram per APL family only**

It is further ordered that, the allottee G.P.S.S./W.C.C.S shall deposit the ex-mill price of wholemeal atta only in the shape of Bank Draft/Banker's Cheque payable in favour of name and style of Roller Flour Mills concerned to them and also to obtain necessary endorsement of quantity of whole meal atta to be lifted (wholly or partly) according to allotment, in the 'Permit Book' from Food, Civil Supplies and Consumer Affairs Branch, Kamrup. The Roller Flour Mills in turn shall release wholemeal atta (FAQ) forthwith and also make necessary records in the 'Permit Book' of the allottee GPSS/WCCS Limited showing the cash memo number with date and quantity issued etc.
