ORDER

Consequent upon upward revision of prices of Kerosene Oil (Blue dyed) meant for distribution through 'Public Distribution System' by Ministry of Petroleum and Natural Gas, Government of India, New Delhi and its effect already given by the 'Oil Companies', it has become necessary in public interest to re-fix the ex-depot sub-wholesale price and 'retail sale price' (i.e. end consumer price) of said product.

Therefore, in exercise of the powers conferred by clause 19 read with clause 2(b) and 28(b) of the Assam Public Distribution of Articles Order, 1982 and also clause 4(c) of the Kerosene (Restriction of Use and Fixation of ceiling prices) Order, 1993, (as amended), I, Shri S.K.Roy, ACS Deputy Commissioner, Kamrup District, Amingaon do hereby re-fix the Ex-Depot price and Retail Price (i.e. end consumer price) of kerosene Oil (Blue dyed) at different location of Kamrup Sadar Sub-Division in public interest and for smooth functioning of PDS as below.

Any appointed dealer such as Sub-wholesaler Depot, Retailer, Hawker, Fair Price Shop dealers found involved in selling or offer to sell blue-dyed kerosene oil at a price higher than the price fixed above, shall be liable for prosecution under section 7(i)(a)(ii) of the Essential Commodities Act, 1955 (Central Act 10 of 1955) besides cancellation of dealing licence, for contravention of the provisions of the Assam Public Distribution of Articles Order, 1982 and the Kerosene (Restriction of uses and fixation of ceiling price) Order, 1993 made there under.

This supersedes all previous order of fixation of selling price of Kerosene Oil (Blue Dyed) and the revised price as fixed herein above shall come into force with immediate effect.
