

ORDER

In pursuance of the Directorate of Food Civil Supplies, & Consumer Affairs, Assam, Guwahati's W. T. Message No. DS. 67/2014/7 dated 21/03/2014 the allocation of total **9590.00** quintals **Regular APL** Rice allocation and for the month of **April 2014**, under P.D.S for Kamrup Sadar Sub-Division of Kamrup District and M/S Baghmara Char GPSS Limited under Barpeta District, are hereby made to the nominees as detailed below for public distribution. The nominees are directed **to deposit the Government fixed value of allotted Regular APL Rice to the F.C.I., Guwahati @ Rs. 830.00 per Quintals within 15/04/2014 for the month of April /2014 to arrange lifting of rice therefrom within 20/04/2014, respectively** without fail. They are also directed to submit the arrival report against lifting of Regular APL rice so allotted and issue the same to the appointed retailers (i. e Agents/FPS dealers) attached with them for ultimate distribution amongst APL Family Identity Card holders **excluding MMASY'10 beneficiaries** under P.D.S. at the rate fixed by the undersigned licensing authority. The quantum of distribution will be **25 kg per APL FIC instead of 25.389 Kgs per FIC** as per calculation as it is not possible to monitor the fractual quantity (i.e. .0.762 Gms) and hence it is decided to lapse 144.00 Qtls.


