**ORDER**

In pursuance of the Director of Food Civil Supplies & Consumer Affairs Assam, Guwahati's order issued under Memo No. DS-127/2013/14 Dated-26/06/2013 regarding allotment of whole-meal atta to be produced by the Roller Flour Mills out of Additional APL wheat allotted for the months of April/May/June,2013 and also on the basis of demand analysis assessment of requirement of w/atta per family in the Kamrup Sadar Sub-Division of Kamrup District as submitted by GPSS/WCCS, Inspectors FCS & CA Kamrup I, Dr. J. Balaji, IAS, Deputy Commissioner Kamrup Amingaon in exercise of the powers conferred by clause 26 read with clause 28(B) of the Assam Public Distribution of Articles Order, 1982 do hereby make the sub-allocation of aforementioned whole meal atta to the sub whole sellers of Kamrup Sadar Sub-Division as shown below for lifting from the respective R.F. Mills within 05/08/2013 on payment of price @ Rs. 737.90 per qtls. of W/atta fixed by the Govt. and for distribution of same through Public distribution System at quantam per FIC as shown against their names.

It is further ordered that, the allottee G.P.S.S. Limited/W.C.C.S. shall deposit the ex-mill price of wholemeal atta as per procedure to the Roller Flour Mills concerned and also to obtain necessary endorsement of quantity of whole meal Atta to be lifted (wholly or partly) according to allotment, in the 'Permit Book' from Food, Civil Supplies and Consumer Affairs Branch, Kamrup. The Roller Flour Mills in turn shall release wholemeal atta (FAQ) forthwith and also make necessary records in the 'Permit Book' of the allottee GPSS/WCCS Limited showing the cash memo number with date and quantity issued etc. and distribution is to be completed by 10-8-2013 among the consumers.

Adjustment have been required to make the quantum @ 15 kg per FIC equal to all the GPSS/WCCS with the equal quantities of w/atta produced by the RF Mills. RF mills will accordingly mill the required quantity of w/atta as sub-allocated below.


