

**Duties and Responsibilities.:**

With a view to ensuring doorstep delivery of food grains as per provisions of the National Food Security Act'2013, the committee shall.

1. Ascertain the distances god owns of each individual GPSS/WCCS from the designated depots of Food Corporation of India (first tier).
2. Ascertain the distances of location of Fair Price Shop/Agents of GPSS/WCCS from each GPSS/WCC godowns (second tier)
3. Take necessary steps for inviting expression of interest from transporters associations along with rates chargeable. The FCI model expressions of interest/tender notice may be adopted in the process of selection of transporters. The rates would be valid for 1 year.
4. Assess the quantum of food grains to be sub- allocated to each GPSS/WCCS for both the tiers mention in Para 1 and 2 above and to decide the mode of transport and rates applicable etc.

This order shall come into effect immediately and remain in force until further orders.


