No. KSL. 149/2011/Part.I/6. In compliance to the **decision no. (1)** contained in the minutes of the meeting held on 28.11.2011 under the Chairmanship of the Hon'ble Minister, Food, Civil Supplies and Consumer Affairs, Assam as communicated vide Government memo no. FSA.236/2005/Pt./79dated 23.12.2011, inter-alia in the matter of disposal of un-lifted stock of wheat products lying in form of whole wheat (APL) since December'2010 till date with the Roller Flour Mills of Kamrup and Kamrup Metropolitan District etc., I Shri S.K.Roy, ACS, Deputy Commissioner, Kamrup Amingaon in exercise of the powers conferred by clause-26 read with clause-28 (b) of the Assam Public Distribution of Articles Order, 1982, do hereby make the re-allocation of unlifted stock of **5,276.00 quintals of whole meal atta** (*ex-mill price of whole meal atta is Rs.737.90 per quintal*) as **December '2011 quota** to be produced out of **total 5,554.00 quintals of accumulated balance stock of 'Regular Quotas of whole wheat'** lying as a whole with the under mentioned Roller Flour Mills for the period **from December'2010 to March'2011** , for its distribution through PDS/TPDS net work @ **5 (five) kilogram amongst per APL family only** on production of Family Identity Cards and payment prices already fixed in this regard.

Pending decision into the matter reflected in **decision no. (12)** contained in the minutes of the meeting held on 28.11.2011, as communicated vide Government memo no. FSA.236/2005/Pt./79 dated 23.12.2011 for arranging an alternative mode of payment, the allottee G.P.S.S./W.C.C.S shall deposit the ex-mill price of whole meal atta @ Rs. 737.90 per quintal in the shape of Bank Draft/Banker's Cheque payable in favour of name and style of concerned Roller Flour Mills and to obtain necessary endorsement of quantity of whole meal atta to be lifted (wholly or partly) in the 'Permit Book' issued to them by this office and **must complete lifting of cent percent quantity of whole meal atta allotted to them within 20.01.2012 without fail.**

The Roller Flour Mills in turn shall release **whole meal atta (FAQ)** forthwith and also make necessary records in the 'Permit Book' of the allottee GPSS/WCCS Limited showing the cash memo number with date and quantity issued etc.

It is further ordered that the Roller Flour Mills shall keep the un-lifted stock of wheat bran as 'reserved stock' to meet any exigent requirement to feed the animal population during flood which may likely to occur in Kamrup District in ensuing monsoon season.

This order shall come into force with immediate effect.

- 7 The Secretaries of all GPSS/Wholesale CCS Limited. Under Kamrup Sadar Sub-Division. They are directed to lift the allotted quantities of wholemeal atta **within 20.01.2012 without fail** and to issue the same to the consumers through F. P. Shop holders/Agents.
- 8 The District Informatics Officer, NIC, Kamrup for information. He is requested to publish this allotment in the District *website* as per Government Standing instructions.
